# Background

In the European Union, comparative assessment is required for plant protection products (PPP) which contain an active substance that has been identified as a candidate for substitution according to Articles 24 and 50 in Regulation EC 1107/2009. Article 50 states that countries shall assess PPPs containing substances listed as candidates for substitution, with the aim of substituting them, whenever possible, with non-chemical control or prevention methods, or with products containing substances presenting less risk. The comparison is performed in regard to efficacy, health and environmental aspects, and conducted at National level. EU Member States must take account of the economic and practical issues around any chemical or non-chemical alternative, and resistance implications, as well as consequences on minor uses. In response to this, EPPO held the *Workshop on the development of principles for Comparative Assessment in the framework of substitution* (Brussels, 2009-05-06/07) which looked at the efficacy related aspects. A summary of the Workshop recommendations is presented below. One of the main outputs was the recommendation to develop an EPPO Standard. EPPO Standard PP 1/271 *Guidance on comparative assessment* was approved in 2011 (and revised in 2015) and is made available (see link in the next page) for ease of reference during this Workshop.

### Summary of previous recommendations (EPPO Workshop 2009)

These are presented to assist in the Workshop discussion in addition to EPPO Standard PP1/271 and the references reported on the next page.

#### Efficacy

Guidance/clarification is needed to address the following points:

- What are the specific efficacy data requirements for the comparison of control methods?
- How should similarity in terms of efficacy be defined? The Swedish tiered approach would be a good starting point, and should be kept as broad and simple as possible (not too prescriptive).
- It is difficult to compare products containing multiple active ingredients. Some guidance is needed.
- For chemical control, products are compared to a reference product. Such direct comparisons may not be possible for non-chemical control methods.
- The levels of control used or required by Member States vary. This will need to be addressed to facilitate zonal mutual recognition.

#### Practical/economic considerations

Guidance/clarification is needed to address the following points:

- There is no simple, defined guidance for consideration of economic factors.
- How should information be collected?

#### Minor uses

Guidance/clarification is needed to address the following points:

- Guidance is needed for comparing different cropping systems.
- Clarification of criteria for comparing efficacy data between MS, since this may hamper mutual recognition. There should be sufficient flexibility to facilitate MR processes.
- Some general principles are needed for comparison between chemical and non-chemical control methods as data are unlikely to exist for all control alternatives.

#### Resistance

Guidance/clarification is needed to address the following points:

• There should be a clear definition of what constitutes sufficient phytosanitary measures for dealing with crop protection issues.
